The following conditions of service are mutually agreed between Mare Owner/Agent, named above and							
Twisted K Ranch, LLC upon execution of this contract:							

1. Fees: The Mare Owner/Agent agrees to pay a breeding fee of \$1000.00 (USD).

This includes a \$250.00 (USD) NON-REFUNDABLE booking fee which is payable upon execution of this contract to Twisted K Ranch, LLC. The balance of the stud fee \$750.00 (USD) is due prior to the first semen shipment payable to Twisted K Ranch, LLC. Mail payment to: Twisted K Ranch, LLC 172 Burdick Road Milford, NY 13807 Venmo & Paypal are also accepted.

2. **Shipment/ Collection Expenses:** All shipping/collection expenses are to be paid to Myers Equine Center, LLC prior to scheduling your first shipment. Myers Equine Center, LLC is payable in the amount of \$825.00 which includes collection and round trip shipping. A separate agreement is required to be put on the calendar at a first come first serve scheduling for the 2025 breeding season.

- 3. **Condition of Mare:** The Mare must be in good physical and sound breeding condition and free of infection, and, except for maiden mares, a negative intrauterine culture and cytology. The Mare Owner agrees to keep the Mare in good physical condition throughout pregnancy. The responsibility for conception is on the Mare Owner. Therefore, a qualified, experienced licensed veterinarian competent in the use and handling of frozen semen should perform the insemination. Twisted K Ranch, LLC may refuse to ship semen if it believes the insemination is not proper or the mare is not healthy. Twisted K Ranch, LLC reserves the right to request a negative uterine culture and a uterine biopsy performed prior to shipment of semen or upon a rebreed if the mare does not settle on the first breeding. The Mare Owner agrees to comply with all requirements concerning the use and handling of frozen semen.
- 5. **Frozen Semen Disclaimer:** Semen is shipped on a first call, first serve basis upon complete payment and return of both the Breeding Contract with Twisted K Ranch, LLC and the Frozen Semen Contract with Myers Equine Center, LLC. Twisted K Ranch, LLC makes no guarantee that frozen semen will be available for transportation on any specific day and it is important that communication is transparent two weeks prior to planned breeding. Twisted K Ranch, LLC makes no representation of warranties, expressed or implied, regarding the frozen semen delivered under this agreement, including and without limitation, representations, or warranties that the frozen semen will safely reach the insemination point without losing its integrity, quality, or other characteristics. Twisted K Ranch, LLC also shall not be responsible for delayed, lost, or mishandled deliveries.
- 6. **Billing:** All fees shall be paid in full before cooled semen is picked up or shipped. Semen will not be shipped to any mare unless a current credit card number, expiration date and 3 digit security code is on file with Twisted K Ranch, LLC and Myers Equine Center, LLC or a check is deposited and cleared. In the event there are any other fees incurred, monthly statements shall be mailed for service herein provided and are due and payable upon receipt. Statements not paid within 30 days will be subject to a finance charge.
- 7. **Breeders Certificate:** A "Breeders Certificate" will be issued upon notification of the birth of the foal, only after all fees are paid by the mare owner. Mare owners must submit confirmation of pregnancy by October 1st, 2025 so that breedings can be submitted.
- 8. Live Foal Guarantee: Confirmation of pregnancy by ultrasound starting at 14 days post ovulation continuing to the 45<sup>th</sup> day is REQUIRED TO MAINTAIN THE LIVE FOAL GUARANTEE. If ultrasound proof is unavailable, Mare Owner agrees to have the mare checked for pregnancy by a licensed veterinarian within 30 days of insemination. Mare Owner agrees to provide the results of the ultrasound(s)/pregnancy exam(s) to Twisted K Ranch, LLC no later than 30 days following the insemination.

A live foal is defined as a newborn foal which stands and nurses without assistance. Should a live foal not be produced from this breeding a rebreed will be honored for the following year with a rebreed fee of \$500.00 (USD). Rebreed privileges shall apply only if Twisted K Ranch, LLC is notified within seven days of birth of the foal , and Twisted K Ranch, LLC receives a veterinarian's statement confirming death.

**Rebreed:** If the mare absorbs or aborts a pregnancy after having been checked in foal, or if the mare fails to conceive during normal breeding season, the Mare Owner is entitled to one rebreed during the 2025 season

and a second during the 2026 season (maximum of two rebreeds). Each rebreed is contracted for a fee of \$500.00 (USD) which does not include shipping and collection. Rebreed privileges shall apply only if Twisted K Ranch, LLC is notified within seven (7) days of an ultrasound confirming that the mare is not pregnant or receives a veterinarian's statement confirming abortion.

- 9. **Death of Mare:** If the mare dies, or is deemed unfit to breed, during the breeding season (a veterinarian report will be required as verification) a substitute mare, owned by the same owner and approved by the Stallion Owner may be bred without any additional breeding fee, but will be charged current collection and shipping fees. Fees: The Mare Owner/Agent agrees to pay a breeding fee of \$1000.00 (USD).

This includes a **\$250.00** (USD) NON-REFUNDABLE booking fee which is payable upon execution of this contract to Twisted K Ranch, LLC.

The balance of the stud fee **\$750.00 (USD)** is due prior to the first semen shipment payable to Twisted K Ranch, LLC.

**Shipment/ Collection Expenses:** All shipping/collection expenses are to be paid to Myers Equine Center, LLC prior to scheduling your first shipment. Myers Equine Center, LLC is payable in the amount of \$475.00 which includes collection and one way shipping. (\$375.00, if picked up at Myers Equine Center, LLC) A separate agreement is required to be put on the calendar at a first come first serve scheduling for the 2025 breeding season.

**Condition of Mare:** The Mare must be in good physical and sound breeding condition and free of infection, and, except for maiden mares, a negative intrauterine culture and cytology. The Mare Owner agrees to keep the Mare in good physical condition throughout pregnancy. The responsibility for conception is on the Mare Owner. Therefore, a qualified, experienced licensed veterinarian competent in the use and handling of chilled semen should perform the insemination. Twisted K Ranch, LLC may refuse to ship semen if it believes the insemination is not proper or the mare is not healthy. Twisted K Ranch, LLC reserves the right to request a negative uterine culture and a uterine biopsy performed prior to shipment of semen or upon a rebreed if the mare does not settle on the first breeding.
